# CITY OF HUDSONVILLE OTTAWA COUNTY, MICHIGAN CHAPTER 5 ANIMALS CODE OF ORDINANCES 

## SECTION 5-1

Chicken means a subspecies of the species Gallus domesticus. This does not include roosters which shall be considered prohibited for the purposes of this chapter.

## SECTION 5-2 (C)

(c) Chickens. No person shall own, posses, harbor, shelter, keep or have custody of chickens except as provided under Section 5-3 (b) of this chapter.

## SECTION 5-3 (B)

(b) Keeping of chickens
(1) The keeping of chickens shall be done on a noncommercial basis while limiting and mitigating any potential adverse impacts. The keeping of chickens shall be exclusively used by the people occupying the property as a locally grown food source for the consumption of eggs or meat.
(2) A maximum of four chickens may be kept per parcel if the parcel is $1 / 2$ acre in size or less, five chickens if the parcel is $1 / 2$ to one acre in size; and six chickens if the parcel is over one acre in size. Roosters are prohibited.
(3) The outdoor slaughtering of chickens is prohibited.
(4) Chickens shall be provided with a covered enclosure and must be kept in the covered enclosure or an adjoining fenced enclosure at all times.
(5) All covered enclosures or fenced enclosures shall be located in the rear yard, shall be no closer than five feet to any property line, and shall be located no closer than 25 feet to any residential structure.
(6) The total square footage of any covered enclosure and fenced enclosure shall not exceed 80 square feet and shall be a maximum of eight feet in height.
(7) Coops and runs must be tended regularly. Accumulation of waste materials (feed, manure and litter) is prohibited. All waste materials shall be disposed of so as not to create a nuisance.
(8) All covered enclosures shall be constructed in such a way as to prevent rats, mice, or other rodents or predators from being harbored underneath or within the walls of the enclosure. The enclosure shall be constructed in a workmanlike manner. The coop and pen must be completely enclosed with a top and/or cover.
(9) Materials used to construct the enclosed areas shall exclude tarps, plastic, fabric, rubber, paper, cardboard, or other non-traditional building materials.
(10) All feed and other items associated with the keeping of chickens likely to attract rats, mice, or other rodents or vermin shall be secured and protected in sealed containers.
(11) Egg-laying chickens shall be kept in compliance with the Michigan Department of Agriculture Generally Accepted Agricultural and Management Practices for the Care of Farm Animals, as amended, except as otherwise provided in this section.
(12) Prior to installation of any backyard chicken enclosure or keeping of any backyard chickens, a fully completed permit application shall be submitted to, and permits shall be issued by, the Zoning Department. This includes payment of the required fee.
(13) If any provisions of this ordinance are violated at any time the city reserves the right to revoke the permit.
