City Commission Minutes

Mayor Northrup called the virtual meeting of the Hudsonville City Commission Work Session to order on Tuesday, September 8, 2020 at 6:00 PM.

Present: Mayor Northrup, Commissioners Brandsen (6:08pm), Bolhuis, DeVree, Leerar, Raterink, Steigenga, City Manager Waterman, DPW Superintendent Miller, Planning/Zoning Director Strikwerda, City Engineer Devries and City Clerk VanSlyke.

9436. 32nd Ave. Water Booster Station Property Discussion.
Waterman stated that this property is largely unused due to the purchase of new equipment. The city had been keeping this property as a backup system but the equipment will need considerable upgrades to be a safe and effective backup system. The City Commission discussed backup option recommendations from City Engineer Devries and City Manager Waterman. The City Commission was in a consensus that they would like Waterman to look into plans and costs for running new lines that would serve as an effective backup. Raterink commented, that historically the booster station was installed to halt further commercial development on 32nd Avenue. If the Water Booster Station is no longer needed, then the City Commission will decide what to do with the property at that time.

9437. Hudsonville Communication Strategy.
Mayor Northrup and Commissioner Steigenga assisted city staff on the creation of a Hudsonville Communication Strategy Matrix. It is a helpful tool that will assist staff on when and who to contact in various situations. This is a living document that can be amended as needed.
