Cedar Crest Dairy of 5800 & 5850 Balsam Drive, Hudsonville, MI 49426 has submitted a Dimensional Zoning Variance request to reduce the rear-yard building setback to 10' where 20' is required in accordance with Section 2.04.15 E.1.d.ii. from the City of Hudsonville Zoning Ordinance. A Dimensional Variance was also submitted to request a 40' tall building when 35' is the required maximum in accordance with 2.04.15 G.1.c. from the City of Hudsonville Zoning Ordinance.

Cedar Crest Dairy of 5800 & 5850 Balsam Drive, Hudsonville, MI 49426 has submitted a Site Plan Amendment in accordance with Chapter 6 Article 2 Section 6.02.10 of the City of Hudsonville Zoning Ordinance for a 32,936 s.f. building addition and 24 additional parking spots.
